ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. **Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.**

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comments related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

1. How the LEA will, to the greatest extent practicable, implement prevention and mitigation policies in line with the most up-to-date guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning;
2. How the LEA will ensure continuity of services, including but not limited to services that address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;
3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:

- a. Universal and correct wearing of [masks](#);
- b. Modifying facilities to allow for [physical distancing](#) (e.g., use of cohorts/podding);
- c. [Handwashing and respiratory etiquette](#);
- d. [Cleaning](#) and maintaining healthy facilities, including improving [ventilation](#);
- e. [Contact tracing](#) in combination with [isolation](#) and [quarantine](#), in collaboration with State and local health departments;
- f. [Diagnostic](#) and screening testing;
- g. Efforts to provide COVID-19 [vaccinations to school communities](#);
- h. Appropriate accommodations for children with disabilities with respect to health & safety policies, IEPs and 504s;
- i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021. * The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current school year. An LEA may use a different plan template or format provided; it includes all the elements required by the ARP Act, as listed above.

* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.

1. **How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?**

To the maximum extent practical, the LEA will follow guidance from the CDC and PA Department of Health to reopen and operate school facilities for in-person learning continuously and safely.

The District will follow the guidelines of the CDC and PA DoH in regard to masking. At this time the recommendation is indoor masking for staff, students and visitors. The Administration will modify masking requirements based upon PA DoH and CDC recommendations. Students and staff will maintain distancing requirements as much as possible. Hand sanitizer stations will be maintained in each entrance area; students and staff will be encouraged to use them before entering the buildings. Routine cleaning of any utilized spaces will be performed. Additional cleaning will be implemented on an as needed basis. Water drinking fountains will continue to be turned off. Water filling stations will be available. Students and staff are encouraged to bring their own water bottles.

2. **How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?**

Educational Delivery Model/Academics

- Parents have the option for full time, in-person learning.
- Parents have the option of participating in the Southeast Delco Cyber Program.

Social and Emotional Learning (SEL) Plan

DCIU will conduct a comprehensive school audit focused on the social and emotional learning supports for students. Deliverables will include:

Program Audit activities conducted September 1-30, 2021:

- Surveys of students, teachers, support staff, administrators, and parents.
- Focus groups and interviews of students, teachers, counselors, support staff, and building administrators.

- Meetings with school climate team leaders (instructional support teams, PBIS, student assistance programs).
- Data review of current school discipline data and overall performance data to analyze opportunity and equity gaps.
- Review of current policies, handbooks, and applicable documents that illustrate supports for students' social and emotional growth and well-being.

Final report delivered by October 15, 2021:

- Research on SEL and student well-being as related to best practices, federal and state guidance.
- Data analysis that illustrates strengths, needs, and overall recommendations for social and emotional programming.
- Recommendations on resources and practices to support SEL.
- Recommendations that are personalized and developmentally appropriate for each level which scaffold to provide a strong K-12 program of district services.

There will be presentations by DCIU of audit findings for district administration and other stakeholder groups as needed.

Student Health and Food Services

- The District will participate in the United States Department of Agriculture (USDA) pandemic flexible meal programs. These programs are available free of charge for each child in the household up to age 18. The Programs include:
 - Return to School Program - Beginning September 7, 2021, following the Seamless Summer Option Waiver, daily breakfast and lunch will be available at the school for students attending in-person instruction and the weekly meal pick up will continue for students who are attending the Southeast Delco Cyber Program.

<p>f. <u>Diagnostic</u> and screening testing;</p>	<p>Parents will be encouraged to conduct daily health screenings.</p> <p>School nurses will follow PA Department of Health guidance related to communicable diseases including <u>COVID-19</u>.</p> <p>Students and staff will report any exposures to COVID-19 or positive test results to the school nursing staff and to the coaching/athletic staff.</p> <p>The District will maintain personal protective equipment for use by school nurses and isolation room staff when individuals become ill.</p>
<p>g. Efforts to provide <u>vaccinations to school communities</u>;</p>	<p>The District will participate in vaccination initiatives offered by the PA Department of Health or the Commonwealth of PA.</p>
